### **Pain Parity for Wisconsin**

#### **Preventing Opioid Use Disorder Before It Begins**



#### Pain is one of the most common reasons people visit their doctor.

Each year, nearly 80 million Americans<sup>i</sup> seek treatment to manage acute pain symptoms and opioids are often prescribed as a solution. While they can be effective, they can also pose significant health risks and increase chances of opioid dependency.<sup>ii</sup>

But breakthroughs in pain medication are enabling patients to have a choice in their pain management. Amidst the ongoing opioid epidemic, it is critical that patients have access to the treatments they want and need to address their pain.



# Need for increased access to all pain treatment options

- Within one year of receiving an opioid medication to manage acute pain, approximately 85,000 Americans were diagnosed with an opioid use disorder.
- Prescribing rates have fallen, but opioid use disorders and overdoses remain high. In 2023, Wisconsin reported:
  - More than 2,400 opioid-overdose related emergency room visitsiv
  - More than 1,421 opioid overdose deaths<sup>v</sup>
  - Spending about \$8 million on naloxone<sup>vi</sup>
  - 32.8 opioid prescriptions per 100 persons<sup>vii</sup>
- Furthermore, in Wisconsin, opioid use disorder cost Medicaid over \$433 million in excess costs in 2022.



# Pain parity legislation for equal access to pain treatment options

Across the country, states are introducing legislation to expand access to non-opioid treatments and therapies. These policy efforts, often referred to as "pain parity" legislation, address the health insurance barriers many patients face when trying to access non-opioid treatment options. Pain parity legislation ensures patients are not disadvantaged when accessing non-opioid options by:

- Prohibiting the use of utilization controls such as prior authorization and step therapy
- Equalizing cost-sharing for the non-opioid prescription drug and the opioid prescription drug



### Pain parity legislation in Wisconsin

#### A.B. 499 | S.B. 492

Representatives Clint P. Moses (R-92), David Armstrong (R-67), Elijah R. Behnke (R-6), Cindi Duchow (R-97), Rick Gundrum (R-58), Daniel Knodl (R-24), Paul Melotik (R-22), Jeffrey Mursau (R-36), Jerry L. O'Connor (R-60), Chuck Wichgers (R-84), and David Murphy (R-56) and Senators Jesse L. James (R-23), Kristin Dassler-Alfheim (D-18), and Sarah Keyeski (D-14) introduced A.B. 499 and S.B. 492, legislation that aims to increase access to non-opioid pain treatment options by:

- Requiring health insurers to cover for at least two FDAapproved non-opioid prescription medication treatment options and three alternative nonpharmacological treatment modalities
- Prohibiting utilization controls that are more restrictive or extensive than those for opioids
- Requiring health insurers to provide information about the pain management access plan to enrollees and health care providers and to make the plan available on its website
